ORDER GRANTING MOTION TO VACATE  
SCHEDULING ORDER

---

ISSUED: November 21, 2023

On October 5, 2023, the Public Service Commission (PSC) issued a Scheduling Order in this docket. On November 17, 2023, Rocky Mountain Power (RMP) filed a Motion to Vacate Schedule and Request for Expedited Treatment ("Motion to Vacate Schedule"). RMP requests the PSC vacate the Scheduling Order to allow RMP to work with the Utah Division of Forestry, Fire, and State Lands ("FFSL") to revise RMP's Wildland Fire Protection Plan (WFPP). RMP states it will file its revised WFPP as soon as possible, but no later than February 29, 2024. RMP requests the PSC hold a scheduling conference after RMP files its revised WFPP to discuss amended Scheduling Order deadlines.

In the Motion to Vacate Schedule, RMP represents it has conferred with the Division of Public Utilities (DPU) and the Office of Consumer Services (OCS) and that both DPU and OCS have indicated they do not oppose the Motion to Vacate Schedule.

Good cause appearing, and based on RMP's representation that the DPU and OCS do not oppose the Motion to Vacate Schedule, the Motion to Vacate Schedule is granted.
