Good morning, Kevin.

Question number one is asking about Rocky Mountain Power's rates. Anything to do with them, you will have to ask them. With Hurricane City, you would pay the current rate for solar customers according to our policy.

Question number two, yes, your solar system export can be limited, but it depends on how big of a system you have. Hurricane City policy restricts the amount of energy that the homeowner is allowed to export onto the grid to 6 kw. So, if your system is capable of exporting more than 6 kw, then you will need to limit the export to 6 kw and provide proof (ie. A picture of the settings) to the Power Dept. that your system is limited.

1) My solar system was installed in 2019 and, based on when I signed the Contract between Rocky Mountain and myself, I was under Schedule 136. Will I remain with Schedule 136 or be moved to Schedule 137?

2) Will or can my solar system's generated excess power be "choked" down or restricted going back to the grid?
