ORDER GRANTING MOTION TO VACATE SCHEDULING ORDER AND NOTICE OF VIRTUAL STATUS CONFERENCE

On November 24, 2023, the Public Service Commission (PSC) issued a Scheduling Order and Notice of Hearing ("Scheduling Order") in this docket.
