REQUEST FOR SCHEDULING CONFERENCE

Kennecott Utah Copper LLC (“Kennecott”) and Rocky Mountain Power, a division of PacifiCorp (“RMP” or “Company”) (collectively, the “Parties”) hereby file this request for a scheduling conference for the Public Service Commission of Utah (“Commission”) to consider the Stipulation and Settlement Agreement filed by the Parties contemporaneously herewith.

At the August 21, 2024 status conference, the Parties informed the Commission that they had reached agreement on a new electric service agreement and that the parties would seek to execute the new agreement in the coming weeks. Because it was not then known how long each Party’s internal review and approval process would take, the Parties did not request that the Commission set a status or scheduling conference at that time. The Parties indicated that once the new electric service agreement had been executed, they would reach out to the Commission and request a new scheduling conference.

As set forth in the Stipulation and Settlement Agreement filed contemporaneously herewith, the Parties have executed the new electric service agreement and request a public hearing for the Commission to consider it. The parties hereby request that the Commission set a scheduling conference for the Parties and other stakeholders to set a hearing for the Commission's consideration of the Stipulation and Settlement Agreement and the new electric service agreement.

The Parties are aware of the upcoming hearing for Phase I of the Company's general rate case filing in Docket No. 24-035-04 and request that the Commission set a scheduling conference as soon after the conclusion of the Phase I hearing as is convenient for the Commission.
