DISCOVERY

NOTICE OF HEARING

The PSC will conduct a hearing in this docket on **Wednesday, March 5, 2025, beginning at 9:00 a.m.** The hearing will be held in the **Fourth Floor Hearing Room 403, Heber M. Wells Building, 160 East 300 South, Salt Lake City, Utah.** All parties must have their witnesses in attendance and prepared to testify. Any person desiring to attend this event must show government-issued photo identification to be admitted past the building security station. If any party desires to convert this in-person hearing to a virtual hearing, they may file a request with the PSC after the February 21, 2025 reply comment deadline.
