Rocky Mountain Power's Utah Carbon Reduction Progress Report

Compliance Filing

On February 7, 2024, Rocky Mountain Power ("the Company") received a letter from the Public Service Commission of Utah ("Commission") acknowledging the Company's 2024 Carbon Reduction Progress Report ("Report") as meeting the reporting requirements under the Utah Energy Resource Procurement Act ("Act"), Title 54 Chapter 17 Section 604. The Commission also directed the Company to update the Report to reflect the impact of its decision to suspend the 2022 All Source Request for Proposals ("2022AS RFP") on the Company's ability to reach the 2025 target under the Act by May 3, 2024. In compliance with the Commission's directive, the Company submits the following explanation as to why no updates to the Report are required to reflect the suspension of the 2022AS RFP.

None of the resources in the 2022AS RFP were scheduled to be commercially operational by 2025. Therefore, the numbers and information regarding the Company's progress towards the 2025 target in the Report did not include any generation or renewable energy credits from resources in the 2022AS RFP. The suspension of the 2022AS RFP has no impact on the progress towards the 2025 target in the Report. The Company is positioned to meet its 20 percent target requirement of an estimated 5,029,589 megawatt-hours of renewable energy in 2025 from existing Company-owned and contracted renewable energy resources, so no updates to the Report are required to reflect the suspension of the 2022AS RFP.
