ISSUED: January 17, 2025

On January 14, 2025, the Division of Public Utilities (DPU) filed a Motion for Leave for Witness Philip DiDomenico to Appear Remotely at Hearing and Request for Expedited Consideration ("DPU's Motion"), requesting the Public Service Commission (PSC) permit Mr. DiDomenico to testify electronically at hearing. DPU represents it has conferred with the other parties, and they have authorized DPU to represent they do not oppose the DPU's Motion.

On January 15, 2025, Rocky Mountain Power (RMP) filed a Motion Requesting Leave for Witness to Appear Telephonically ("RMP's Motion"), requesting the PSC permit Robert Meredith to testify electronically at hearing. RMP also represents it has conferred with the other parties and no party objects to Mr. Meredith's remote participation.

Based on the representations that no opposition exists and good cause otherwise appearing, the DPU's Motion and RMP's Motion are granted.
