On March 28, 2024, Rocky Mountain Power, a division of PacifiCorp (“Rocky Mountain Power” or “Company”), pursuant to the Public Service Commission of Utah (“Commission”) order in Docket No. 22-035-03, submitted information substantially similar to the requirements for major plant additions under Utah Admin. Code R746-700-30 (“MPA Equivalent Information”) in advance of its Application for a general rate case, which is anticipated to be filed on or about April 30, 2024.

Subsequent to filing, the Company identified an additional document that is responsive to the Significant Energy Resource Filing Requirements (“SER FR”) A.11 for the Rock Creek II wind project. The Company hereby submits a supplement to SER FR A.11 to provide the confidential operations and maintenance agreement for the Rock Creek II wind project as Confidential Attachment SER FR A.11-3k.


