ORDER CANCELING PHASE II HEARING DATES AND NOTICE OF HEARING RE: SETTLEMENT STIPULATION RESOLVING PHASE II ISSUES

ISSUED: January 13, 2025

On January 13, 2025, Rocky Mountain Power's (RMP) counsel sent an email to the Public Service Commission (PSC), notifying the PSC "[t]he parties have reached a unanimous settlement on all Phase II issues" that is expected to be filed no later than Tuesday, January 14, 2025.<sup>1</sup> The email further requested the PSC set a hearing date to consider the forthcoming settlement stipulation, volunteering any date from January 15-17, 2025, as potential hearing dates. Finally, the email asked the PSC consider setting a virtual or "hybrid" hearing to allow any non-local witnesses to testify electronically.

Accordingly, the PSC cancels the previously noticed hearing dates, specifically January 15 and 16, 2025, wherein the PSC was to consider Phase II issues.

#### **NOTICE OF HEARING**

The PSC will conduct a hearing to consider the parties' settlement stipulation regarding Phase II issues on **Friday, January 17, 2025, beginning at 10:00 a.m., Fourth Floor Hearing Room 403, Heber M. Wells Building, Salt Lake City, Utah.** The PSC will accommodate the parties' request to allow out-of-state witnesses to testify

electronically. Electronic participation will be via Google Meet at the following link: ([meet.google.com/yrd-cxdz-ynd](https://meet.google.com/yrd-cxdz-ynd)). In the event of unresolvable technological problems related to the hearing's video conferencing, participants should use the following audio-only participation information: 631-743-5246 PIN: 502 206 347#.

The PSC asks the parties to make available, electronically or in-person, any of their respective witnesses who submitted written testimony addressing Phase II issues to answer any questions of the commissioners. The PSC does not have a specific intention to call any such witness. However, making such witnesses available at the hearing will ensure the PSC's questions can be addressed and mitigate the risk such questions might delay the PSC's evaluation of the settlement's terms.

Any person desiring to attend the hearing in-person must show government-issued photo identification to be admitted past the building security station. The PSC will stream audio and video of the hearing, which will be accessible through a link on the PSC's website.
