ISSUED: September 13, 2024

On August 15, 2024, PacifiCorp filed with the Public Service Commission (PSC) its Semi-Annual Hedging Report ("Report"). The PSC subsequently issued an action request to the Division of Public Utilities (DPU) and a Notice of Filing and Comment Period, inviting comments on PacifiCorp's Report by September 16, 2024, and reply comments by October 1, 2024. On September 11, 2024, the DPU filed a request for an extension of the comment deadline to November 15, 2024, noting it would need additional time to complete a more comprehensive analysis of the Report. To afford all interested persons additional time to submit comments in this docket, we amend the comment period as follows: Any interested person may submit comments on PacifiCorp's Report on or before **Friday, November 15, 2024**, and reply comments on or before **Monday, December 2, 2024**.
