Investigation, Re: Open Market Operations

SECOND ORDER TO FILE STATUS REPORT

---

ISSUED: July 12, 2024

On April 4, 2024, the Public Service Commission (PSC) issued its Order to File Status Report in this docket. The PSC ordered Rocky Mountain Power (RMP) and the Division of Public Utilities (DPU) to file a status report by July 1, 2024, apprising the PSC of the progress of discussions between RMP, DPU, and other participating stakeholders regarding the PSC's investigation of open market transactions. On July 1, 2024, RMP submitted its Status Report stating it has "developed proposed documentation to provide to the DPU with additional information regarding [RMP's] open market operations."<sup>1</sup> RMP requests additional time to continue these discussions and recommends the PSC require another status update by August 30, 2024.

Accordingly, the PSC orders RMP and DPU to file a status report apprising the PSC of the progress of their discussions and recommending next steps for this proceeding on or before **Friday, August 30, 2024**. DPU and RMP may file a single, joint status report, or they may file separate reports in the event filing jointly proves impracticable.
