Re: *Rocky Mountain Power's Proposed Changes to Electric Service Schedule No. 140, Non-Residential Energy Efficiency Program, Docket No. 24-035-T09*

Dear Mr. Snow:

The Public Service Commission of Utah ("PSC") reviewed the September 30, 2024 filing by Rocky Mountain Power ("RMP") proposing changes to Electric Service Schedule No. 140, Non-Residential Energy Efficiency Program ("Schedule 140"). The proposed changes to Sheet Nos. 140.4, 140.5, and 140.6 include:

1. Adjustment to the incentive offerings for motor, building envelope, food service, and heating, ventilation, and air conditioning measures; and
2. Adjustments to incentive structures for variable refrigerant flow (VRF) heat pumps, VRF retrofits; and
3. Expanded equipment eligibility for commercial refrigerators and freezers.

According to RMP, the proposed changes are intended to align with estimated targets RMP identified and plans to include in its November 1, 2024 Deferred Account and Forecast Report in Docket No. 24-035-37.¹ RMP requests an effective date of November 15, 2024.

The PSC also reviewed the comments of the Division of Public Utilities (“DPU”) filed on October 15, 2024. No other comments were filed. DPU confirms that RMP shared the proposed tariff updates with the DSM Steering Committee on September 10, 2024. DPU states it is reasonable and appropriate to adjust RMP’s Schedule 140 as it enables RMP to update its offerings based on market conditions. Accordingly, DPU recommends the PSC approve RMP’s revised Schedule 140 as filed, effective November 15, 2024.

Based on the PSC’s review of RMP’s filing, the comments and recommendations from DPU, and there being no opposition, the proposed revisions to Sheet Nos. 140.4, 140.5, and 140.6 in RMP’s Schedule 140 are approved as filed, effective November 15, 2024.
