PacifiCorp d/b/a Rocky Mountain Power ("Rocky Mountain Power" or "Company") respectfully moves the Public Service Commission of Utah ("Commission") to excuse Company Witness, Mr. Robert Meredith from the hearing in the above-captioned matter, which is scheduled for January 22, 2026. As a witness supporting the Company's application, Mr. Meredith filed direct testimony in this docket. However, no party in the case challenged Mr. Meredith's testimony. Company witness, Mr. Jack Painter, will attend the hearing and present the Settlement Stipulation filed on December 5, 2025. On January 20, 2025, the Company contacted counsel for the intervenors in this docket, including the Division of Public Utilities, Nucor Steel-Utah, a Division of Nucor Corporation, and the Utah Associate of Energy Users and can represent that no party has objected to Mr. Meredith being excused.

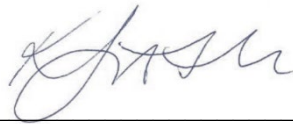

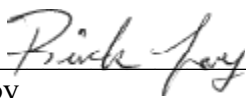
