To Whom It May Concern,

My name is Whitney Brown, and I am a Utahn, new mom, and writer whose work almost always considers the effects of climate change on our planet. I'm writing today to urge you to take actions that will clean up Utah's electricity grid and other forms of infrastructure.

I recently learned that about 80 percent of Utah homes (including mine, unfortunately) are heated by natural gas, which I find sickening. As you know, "natural gas" is just the less scary term for methane, and methane is an extremely powerful fossil fuel, with a greenhouse effect 80 times stronger than carbon dioxide (at least in the short term). I want Utah to move away from fossil fuels as soon as possible, so I strongly support the Utah Renewable Communities Program. As a resident of Provo, my power is not supplied by Rocky Mountain Power, so the program is not available to me; even so, I hope it will be available to as many Utahns as feasible.
