My name is Ray Worthen. I am a life long resident of Utah currently living Morgan County. I am writing to urge the Public Service Commission to approve the Utah Renewable Communities program to allow utility customers the choice to supplement their supply of energy from renewable sources.

As a mechanical engineer I have been following closely the impact of fossil fuels both on the climate and on public health. Utah is currently one of the dirtiest utilities in the nation producing 724 megatons of CO2 per Gigawatt of electricity generated, placing it in the bottom 7 worst States in the Nation. In terms of Nitrogen Oxides generated it is the 4th worst in the nation at 790 Kilotons per Gigawatt generated.

Nitrogen Oxides are known to damage respiratory systems, worsen asthma, and contribute to cardiovascular issues, especially for children, the elderly, and those with existing lung problems.

They are also the source of acid rain and are themselves a greenhouse gas that in terms of global warming potential is 275 times greater than CO2.

Currently, renewable energy plants (wind and solar) are less expensive to build that coal plants are just to run. There is no reason we should continue to damage our children's health and future by not supporting more renewable energy sources. This program would add no more than \$3 to \$4 per month to the average residential customer. I strongly urge you to support it.
