Utah Clean Energy (“UCE”) respectfully moves the Public Service Commission of Utah (“Commission”) to excuse UCE from attending the Community Clean Energy Program Authorization Hearing in docket no. 25-035-06, scheduled for December 16, 2025. UCE filed a Petition to Intervene on July 18, 2025, which was granted by the Commission on August 4, 2025. Since intervening, UCE has worked with other parties in this docket to ensure several issues were addressed and has addressed several related issues in other dockets (e.g. 25-035-30, 25-035-22, and 25-035-52). Based on this work, UCE has not submitted testimony in this docket. In the upcoming hearing on December 16, 2025, UCE does not intend to call witnesses, nor does it intend to cross-examine any witnesses.

Therefore, UCE respectfully requests that the Commission issue an Order excusing Utah Clean Energy from attending the Community Clean Energy Program Authorization Hearing in this docket on December 16, 2025.
