My name is Shelley Hill-Worthen. I am currently a resident of Morgan, but I have lived and worked in the Wasatch Front for the majority of my life. I'm an engineer and architect who has a keen interest in sustainable energy. I'm also a daughter, wife and mother who cherishes my family's long history in Utah.

I am saddened by the continued decline of our air quality and the threat of the collapse of the Great Salt Lake.

When I was pregnant with our son, I developed a severe form of preclampsia whose incidence increases in areas with severe air pollution. Our son was born 6 weeks preterm. In my late 50's I also developed a rare blood cancer that continues to threaten my life. The statistics also suggest that poor environmental quality can be associated with my cancer. I believe that preservation of Utah's air and water will protect families like mine from health disorders.

Hello Public Service Commission,

Thank you for considering the Community Renewable Energy Program. I live in Ogden, one of the communities active in the program. I'm excited for Ogden residents to have the opportunity to choose clean, renewable energy!

Poor air quality in Utah has a significant negative impact on quality of life, health and climate and the shift to clean, renewable energy is urgently needed.

The Utah Renewable Communities plan offers customers an affordable choice to supplement current energy mix with renewable clean energy with the potential to shift 25% of the energy produced by RMP in Utah to renewably sourced clean energy.

The potential \$3-4 monthly increase is small relative to the benefits and residents may opt out or seek assistance if this is burdensome. However, RMP's proposal to impose excessive administrative costs and to undervalue clean energy resources will increase the cost and undermine the program's success.
