


Concerning the Utah Renewable Communities Program  
Docket No. 25-035-06

My name is Ray Worthen. I am a life long resident of Utah currently living Morgan County. I am writing to urge the Public Service Commission to approve the Utah Renewable Communities program to allow utility customers the choice to supplement their supply of energy from renewable sources.

As a mechanical engineer I have been following closely the impact of burning fossil fuels both on the climate and on public health. Utah is currently has one of the dirtiest utilities in the nation generating 724 megatons of CO<sub>2</sub> per Gigawatt of electricity generated, placing it 7<sup>th</sup> from the bottom. In terms of Nitrogen Oxides generated it is the 4<sup>th</sup> worst in the nation at 790 Kilotons per Gigawatt generated.

Nitrogen Oxides are known to damage respiratory systems, worsen asthma, and contribute to cardiovascular issues, especially for children, the elderly, and those with existing lung problems. They are also the source of acid rain and are themselves a greenhouse gas that in terms of global warming potential is 275 times greater than Carbon Dioxide.

Currently, renewable energy plants (wind and solar) are less expensive to build that coal plants are just to run. There is no reason we should continue to damage our children's health and future by not supporting more renewable energy sources. This program would add no more than \$3 to \$4 per month to the average residential customer.

I am writing to urge you to approve this renewable energy program at rates proposed by the URC Agency Board so that as many people as possible can participate. The millions of dollars proposed by RMP for administrative costs could decimate this program before it ever gets off the ground.

My interests in this program are multi-faceted:

- With the multitude of new energy developments proposed through Operation Gigawatt, an "all of the above" portfolio of energy sources should be developed to support future needs, grow Utah's economy AND improve its environment. This opt-out/citizen choice program for renewables should play just as important - if not greater - role in energy use as the other more traditional methods of energy production.
- Air quality - particularly along the Wasatch Front - can be dismayingly poor. This program, if fully enacted by all of the participating communities, could have a net result of 25% of the energy produced by RMP in the state being renewably-sourced. My name is Shelley Hill-Worthen. I am currently a resident of Morgan, but I have lived and worked in the Wasatch Front for the majority of my life. I'm an engineer and architect who has a keen interest in sustainable energy. I'm also a daughter, wife and mother who cherishes my family's long history in Utah.

I am saddened by the continued decline of our air quality and the threat of the collapse of the Great Salt Lake.

When I was pregnant with our son, I developed a severe form of preeclampsia whose incidence increases in areas with severe air pollution. Our son was born 6 weeks preterm. In my late 50's I also developed a rare blood cancer that continues to threaten my life. The statistics also suggest that poor environmental quality can be associated with my cancer. I believe that preservation of Utah's air and water will protect families like mine from health disorders.

However, I am concerned about Rocky Mountain Power's recent proposals that could undermine the program's success. I urge the Commission to reject RMP's proposals that would undervalue clean energy resources and impose excessive administration costs on participating customers. Approving a fair, community-centered version of this program will help keep electricity rates affordable while advancing Utah's clean energy future.

This program offers Utah the opportunity to diversify energy sources, create jobs, improve air quality, and strengthen energy independence. It will also help support Governor Cox's Operation Gigawatt by adding new power plant capacity at a time when Utah's economy needs it.

We ask that you please approve a version of the program that reflects the priorities of the communities it's meant to serve.

**I am a fifth generation Utahn, born in Salt Lake City, living in Summit County now.**

We are incredibly fortunate to live in an era where clean, renewable resources are now the cheapest electric power option for us.

While there are new and growing sources of human health hazards such as the vanishing Great Salt Lake, the elimination of local coal-fired power plants has made our area a healthier place to live.

**I recommend that you support the Utah Renewables Community program proposal to help finalize the transition to 100% clean renewable power for our local communities.**

I would like to point out two problems with Rocky Mountain Power's objections to the Utah Renewables Community program which they are trying to defund.

**First, I often hear that clean renewable power is not reliable despite facts to the contrary.**

The State of Utah has chosen 75+% fossil fuel electric power generation as base load so we do not actually have a baseload problem in the first place. We also do not suffer from the "dark doldrums" of Europe. Finally, the winter storm grid problems in Texas were shown to be due to natural gas power plants not being correctly winterized and the power outage problem in Iberia was due to grid design, not renewables.

Since renewables are not the reliability problem with a correctly designed grid, I want the full benefit of the spectacular decrease in the cost of renewables and reliable grid storage in our community.

**Second, I am bored with listening to the cheerleading about Utah nuclear power for residential users with no discussion of the cost.**

It is hypocritical for Rocky Mountain Power to shed tears about low cost, reliable renewables while stating that they are going to support First Of A Kind (FOAK) nuclear plants such as TerraPower Natrium despite having no expertise in nuclear power construction or plant operation.

Bill Gates is on record as saying that his Kemmerer Natrium plant will cost up to \$10 billion for 350 megawatts capacity but Rocky Mountain Power refuses to disclose to the public the updated Natrium cost and what it will mean for residential consumers.

I do not want to pay for any of the out of control nuclear capital costs nor the resulting high cost nuclear electricity when there are so much cheaper renewable options available.

**Please support Utah Renewables Community Program and help us move beyond coal and avoid the impending nuclear financial fiasco.**

#### Request Action

- I urge you to approve the Program as proposed by the 19 Utah Renewable Communities
- The initial rate should add no more than \$3-\$4 to the average household's monthly bill
- New clean energy this decade is valuable for Utah and should be fairly valued by Rocky Mountain Power
- Pre-paying five years of admin costs is excessive

#### Concerns with Rocky Mountain Power filing

Rocky Mountain Power recently slashed the value it is willing to pay for new energy sources

- In May, proposed that solar, wind, and thermal avoided costs be reduced by around 40%
- In late-September, the company proposed that solar and wind avoided costs be reduced by 86-87%
- Wants to apply similar valuation framework to URC resources

#### Additional administrative costs

- Rocky Mountain Power proposes that the initial program rate should cover five future years of anticipated administrative costs (\$5million)
- This includes a new full-time staff person who works for RMP at \$154k per year
- The URC Board's estimate only includes only one year of anticipated administrative costs and no new staff position for Rocky Mountain Power

#### Fewer resources

- Rocky Mountain Power assumes that only 120 MW of new clean energy resources will be acquired
- The Board's estimate assumes 600 MW are acquired to satisfy net-100% clean energy by 2030
- If resource costs increase (tariffs, tax credits), net-100% may be delayed beyond 2030
