DISCOVERY

Discovery turn-around times shall be 10 calendar days until May 8, 2025, and 7 calendar days thereafter. Parties shall serve discovery requests and responses on applicable parties by electronic mail. disclosing the document shall provide an electronic copy of the document on CD (or, if an electronic copy is not available, a paper copy).

NOTICE OF HEARING ON INTERIM RATES
