On May 31, 2025, PacifiCorp ("the Company") filed its 2025 Integrated Resource Plan ("2025 IRP") with the Public Service Commission. In the cover letter that accompanied the 2025 IRP, the Company indicated that the supporting information would be available on or around April 11, 2025.
