RMP's continued reliance on outdated coal plants and expensive carbon-capture technology is a risk-laden plan that threatens to drive up energy costs.

More than 80% of RMP's requested rate increases in the last two years were due to high coal and gas costs. Meanwhile, Utah stands to gain millions in tax revenue and thousands of jobs by expanding renewable energy, according to a Sierra Club analysis conducted by Current Energy.. Yet PacifiCorp's plan moves in the opposite direction.

I urge the PSC to reject costly, high-risk continued reliance on fossil fuels and instead push Rocky Mountain Power and PacifiCorp to prioritize affordable, reliable clean energy that benefits Utah families and businesses.
