ROCKY MOUNTAIN POWER'S MOTION TO EXTEND THE PROCEDURAL SCHEDULE

Pursuant to Utah Admin. Code R746-1-301, the Public Service Commission of Utah's (Commission) rules of procedure, PacifiCorp d/b/a Rocky Mountain Power (Rocky Mountain Power or Company) files this Motion to Extend the Procedural Schedule (Motion) in this docket until November 10, 2026.

On August 5, 2025, Rocky Mountain Power filed its Application for Approval of the 2026 Inter-Jurisdictional Protocol (2026 Protocol) with the Utah Public Service Commission (Commission) in this docket. On February 20, 2026, the Company filed a Motion to Suspend the Procedural Schedule and to Suspend Discovery to allow the Company to discuss with parties the proposed sale of the Company's Washington service area to Portland General Electric Company and its effect on the allocation of certain costs under the 2026 Protocol currently pending approval

by the Commission. On March 5, 2026, the Commission issued the Order Granting Motions to Suspend Schedule and Discovery, which included a request that the parties “confer and file a proposed stipulated amended schedule in each docket on or before Tuesday, April 7, 2026.”¹

Rocky Mountain Power and the parties requested an additional 30 days for the parties to file a proposed stipulated amended schedule by Thursday, May 7, 2026. On May 7, 2026, the parties requested an additional 60 days for those discussions to progress further, followed by a subsequent request for additional time, filed on July 7, 2026.

The Company and the parties continue to have productive discussions and respectfully request additional time to continue discussing the company’s application.

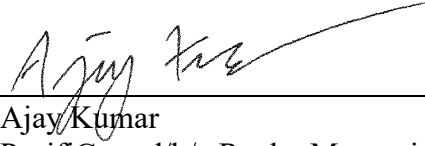
Rocky Mountain Power contacted parties in this proceeding, and the Utah Division of Public Utilities, the Utah Office of Consumer Services, the Utah Association of Energy Users, the Utah Large Customer Group, Western Resource Advocates, Utah Clean Energy, Nucor Steel-Utah, and Sierra Club do not oppose extending the schedule in this proceeding.

For the reasons discussed above, Rocky Mountain Power requests the Administrative Law Judge extend the procedural schedule in this docket to November 10, 2026, at which time the parties propose to file a stipulated amended schedule.

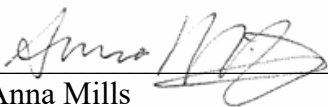
