Pursuant to Utah Administrative Code Rule 746-1 et. seq., Rocky Mountain Power (the “Company”) requests that the Public Service Commission of Utah (“Commission”) schedule a technical conference for the Company to present upcoming changes to its Risk Management & Hedging Program & Policy. Due to the commercially sensitive nature of the Company’s policy and program, making this type of information available to the public could significantly impact the Company’s ability to transact in the best interest of our customers. Therefore, the Company respectfully requests the technical conference be closed to the public to protect against disclosure of confidential information in accordance with Utah Code Ann. § 54-3-21(4). The Company asserts that a closed conference is in the public interest because it will allow PacifiCorp to provide the information and have open, meaningful discussion with the Commission, Division of Public Utilities and Office of Consumer Services.

Accordingly, the Company proposes the Commission limit attendance at the technical conference to individuals entitled to receive confidential information as specified in Commission Rule R746-1-602(1)(a). The Company is willing to allow other interested parties to attend and participate who execute a non-disclosure agreement (“NDA”). Interested parties who wish to attend should contact Katherine Smith at [katherine.smith@pacificorp.com](mailto:katherine.smith@pacificorp.com) to sign the NDA. The Company will provide a list to the Commission of individuals who have executed an NDA two weeks in advance of the technical conference.

The Company has conferred with the Division of Public Utilities and the Office of Consumer Services and provides the following potential dates for the Commission’s consideration to schedule the requested technical conference.






