ISSUED: March 26, 2026

On March 19, 2026, the Division of Public Utilities (DPU) filed a Motion for Leave for Witness to Appear Remotely at the evidentiary hearing scheduled for March 31, 2026 in this docket (“Motion”). Specifically, DPU seeks permission from the Public Service Commission (PSC) allowing DPU’s witness, David Williams, who resides outside of Utah, “to participate in the hearing through virtual means because it is significantly less costly and more efficient and convenient for this out-of-state witness.”¹ DPU further states it has communicated with counsel for the parties in this docket and is authorized to represent that Rocky Mountain Power, the Office of Consumer Services, Nucor Steel-Utah, the Utah Association of Energy Users, Utah Clean Energy, the Utah Large Customer Group, and Western Resource Advocates do not object to Mr. Williams appearing remotely at the hearing.

Based on the representation made by DPU that it is authorized to represent that all parties to this docket do not object to Mr. Williams appearing remotely at the hearing, the Motion is granted. The PSC also appreciates DPU’s statement that DPU
