On October 29, 2025, NWR Limited Partnership (“NWR”) filed its formal complaint against Rocky Mountain Power (“RMP”) in this docket. On November 3, 2025, the Public Service Commission issued a Notice of Filing and Comment Period, establishing December 1, 2025 as the deadline for RMP to submit a response to the complaint, and December 16, 2025 for NWR to submit a reply. On December 11, 2025, NWR filed a Motion to Extend the Deadline for NWR to Respond to RMP Answer and Motion to Dismiss (“Motion”) in this docket. In its Motion, NWR requests an extension until January 13, 2026 to file its reply. NWR states it has conferred with RMP and represents that RMP does not object to the requested extension in the Motion.

Good cause appearing, and based on NWR’s representation that RMP does not object to the Motion, the Motion is granted.
