ISSUED: April 8, 2026

On February 17, 2026, NWR Limited Partnership (“Complainant”) filed a Motion for Partial Summary Judgment (“Motion for PSJ”). On February 23, 2026, Rocky Mountain Power (RMP) filed a Request for Extension (“Initial Request for Additional Time”) allowing it until March 19, 2026, to respond to the Motion for PSJ.

On March 6, 2026, RMP filed a Rule 56(d) Motion to Defer Briefing and Ruling on the Motion for PSJ or, in the Alternative, for Additional Time to Respond (“RMP’s Motion”), explaining that RMP requires discovery and additional time to respond to the Motion for PSJ.

On March 23, 2026, Complainant filed its Motion to Extend the Deadline to Respond to RMP’s Motion (“Complainant’s Request for Additional Time”), requesting the PSC allow Complainant to file its response no later than April 10, 2026.

Complainant represents it conferred with RMP’s counsel, and RMP does not oppose Complainant’s request.

There being no objection and good cause otherwise appearing, Complainant’s Request for Additional Time is granted. For the same reasons, the PSC also grants RMP’s earlier Initial Request for Additional Time, filed February 23, 2026.
