

1	Q.	Please state your name, business address, and present position with PacifiCorp
2		d/b/a Rocky Mountain Power ("PacifiCorp" or "Company").
3	A.	My name is Kenneth Lee Elder, Jr. My business address is 825 NE Multnomah Street,
4		Suite 2000, Portland, Oregon 97232. My present position is Director, Pricing and Tariff
5		Policy.
6		I. QUALIFICATIONS
7	Q.	Please describe your education and professional background.
8	A.	I have a Bachelor's Degree in Agriculture Business from Tarleton State University and
9		a Master's Degree in Agricultural and Resource Economics from Colorado State
10		University. I have been employed by PacifiCorp since July 2016, where I have
11		managed load forecasting and load research. From 2008 through 2016, I was an
12		economist for a natural resource consulting firm. From 2004 through 2008, I was an
13		economist for the University of Alaska Fairbanks. In May 2025, I assumed my current
14		position.
15	Q.	What are your responsibilities?
16	A.	I am responsible for regulated retail rates and cost of service analysis in the Company's
17		six state service territory.
18	Q.	Have you testified in previous regulatory proceedings?
19	A.	Yes. I have previously filed testimony on behalf of the Company in regulatory
20		proceedings in Utah, Oregon, Wyoming and Washington.
21		II. PURPOSE AND SUMMARY OF TESTIMONY
22	Q.	What is the purpose of your testimony in this proceeding?
23	A.	The purpose of my testimony is to present the Company's proposed new Schedule 96,

24		Fire Fund Adjustment, to collect the Utah Fire Fund set forth in Utah Code §54-24-301
25		and the corresponding rate spread and rate design for this schedule.
26		III. FIRE FUND ADJUSTMENT – PROPOSED SCHEDULE 96
27	Q.	What is the Fire Fund Adjustment ("FFA")?
28	A.	As explained in the testimony of Company witness Joelle R. Steward, the Company
29		proposes to establish a Utah Fire Fund (the "Fire Fund") as part of this proceeding. The
30		Company proposes to collect the Fire Fund through a new Schedule 96 - Fire Fund
31		Adjustment ("FFA").
32	Q.	How does the Company propose to allocate the FFA to each customer class?
33	A.	The Fire Fund is intended to serve as a financial backstop to address potential wildfire-
34		related liabilities that could significantly exceed the Company's insurance coverage.
35		Establishing the Fire Fund would create a prudent reserve to cover extraordinary claims
36		and is expected to be viewed favorably by credit rating agencies, thereby supporting
37		the Company's overall financial stability. Because wildfire risk affects all aspects of
38		utility operations, the Company proposes allocating the Fire Fund to each customer
39		class based on an equal percentage of base revenue.
40	Q.	What is the proposed rate design for the FFA?
41	A.	The Company proposes to collect these Fire Fund from customers through a percentage
42		adjustment that would be applied to all base charges including Customer Charges,
43		Power Charges, Facilities Charges, Energy Charges, and Voltage Discounts of the
44		Customer's applicable schedule. The allocation and pricing details for Schedule 96 are
45		provided in Exhibit RMP(KLE-1).

46 Q. Has the Company taken into consideration contract provisions that apply to its 47 customers in developing the proposed rate design? Yes. Consistent with the terms of the contract approved by the Public Service 48 A. 49 Commission of Utah in Docket No. 21-035-69, the proposed FFA rate for Contract 50 Customer 1 is based on the overall percentage increase to tariff customers in Utah. 51 Q. What are the collection amounts and the impact of the proposed FFA? 52 The Company's proposed FFA would collect approximately \$109 million per year, A. 53 totaling about \$1,090 million over ten years. This would result in an increase of 54 approximately 4.48% in current rates for all customers, which translates to about \$3.70 55 per month for an average residential customer. The requested increase is below the 56 maximum rate impacts allowed by state law, specifically Utah Code § 54-24-301(4)(b), 57 which limits fire adjustments approved by the Commission to no more than a 4.95% 58 increase for all customers and no more than \$3.70 per month for an average residential 59 customer. 60 Please describe Exhibit RMP (KLE-1). Q. 61 Exhibit RMP (KLE-1) contains the FFA allocation and the price calculation of the A. 62 proposed Schedule 96. 63 0. Please describe Exhibit RMP (KLE-2). 64 Exhibit RMP (KLE-2) contains the proposed Schedule 96, the revised Tariff Index A. 65 B.1 and Schedule 80. The Company requests that the proposed tariffs become effective on May 1, 2026. 66
