Pursuant to Utah Code Ann. § 63G-4-204(1) and Utah Admin. Code §§ R746-1-109, and R746-1-301, Rocky Mountain Power, a division of PacifiCorp (“Rocky Mountain Power” or the “Company”) respectfully requests the Public Service Commission (“Commission”) for leave to extend the deadline to January 23, 2026 for Rocky Mountain Power to respond to the formal complaint (“Complaint”) filed by James Shelton (“Complainant”).

The Company respectfully requests more time to respond to Mr. Shelton so that the Company can complete a thorough review of the Complainant’s usage history, payment history, and all other issues presented by the Complainant. A number of significant and complex billing issues have been raised through the Complaint and this additional time will allow Rocky Mountain Power to ensure that a full factual picture is presented to the Commission.

For the foregoing reasons, the Company respectfully requests leave to extend the deadline to January 23, 2026 to respond to the Complaint filed by Mr. Shelton.


