Re: Docket No. 25-035-T11 – *Rocky Mountain Power's Tariff Updates*

Dear Mr. Backlund:

The Public Service Commission (PSC) has reviewed the October 10, 2025, filing ("Filing") submitted by Rocky Mountain Power (RMP) proposing updates to RMP's Tariff P.S.C.U. No. 52 ("Tariff"). RMP has identified necessary modifications to incorporate updates previously approved by the PSC into the Tariff ("Tariff Revisions"). RMP included with the Filing revised Tariff Sheet Nos. 31.1, 31.6, 31.7 ("Revised Tariff 31 Sheets"); revised Tariff Sheet Nos. 32.5, 32.6, 32.11 under Service from Clean Energy Facilities ("Revised Tariff 32 Sheets"); a revised Tariff Sheet No. 94.11 under Energy Balancing Account, or EBA ("Revised Tariff 94 Sheet"); a revised Renewable Energy Credits (REC) Balancing Account, or RBA, Tariff Sheet No. 98 ("Revised Tariff 98 Sheet"); a revised Tariff Sheet No. 12R.8 under Line Extensions ("Revised Tariff 12R Sheet"); and a revised Index Tariff Sheet No. B relating to the proposed modifications.

Revised Tariff 31 Sheets: Combines the final rate changes approved in Docket No. 25-035-T10¹ with the modifications to station service language,

subsequently revised further in Docket No. 25-035-T05² as part of RMP's 2024 general rate case ("2024 GRC"), and reflects an August 1, 2025 effective date to align with the PSC's approval in Docket No. 25-035-T04.³

Revised Tariff 32 Sheets: Combines revisions to replace the word "clean" with "renewable" as the PSC approved in Docket No. 24-035-T07,⁴ and reflects an April 25, 2025 effective date to align with Docket No. 25-035-T10, and was further revised in Docket Nos. 25-035-T05 and 25-035-T10 as part of the 2024 GRC.

Revised Tariff 94 Sheet: Combines overlapping changes to Tariff Sheet No. 94.11, which removes obsolete reference to and rates for Tariff Schedule No. 22, which was canceled as a result of the 2024 GRC, and reflects an effective date of July 1, 2025 to align with the effective date of the PSC's EBA order in Docket No. 25-035-01.⁵

Revised Tariff 98 Sheet: Combines modifications to Tariff Sheet No. 98 by removing Tariff Schedule No. 22, adding a sentence to the "Application" section, and reflects an effective date of June 1, 2025 to align with the effective date of the RBA the PSC approved in Docket No. 25-035-13.

Revised Tariff 12R Sheet: Combines an update to the "Extension Allowance" language consistent with PSC approval in Docket No. 24-035-T05⁶ and reflects an effective date of April 25, 2025 to align with Docket No. 25-035-T05.

The PSC has also reviewed the comments the Division of Public Utilities (DPU) filed on October 20, 2025. DPU represents it reviewed the Filing and concludes the Tariff Revisions comply with prior PSC approvals. Accordingly, DPU recommends the PSC approve the Revised Tariff Sheets. No other party filed comments in this docket.
