I was reading through the Action Request Response document and found this minor discrepancy with the Irrigation on page 1. I think this sentence I highlighted should be deleted because it doesn't apply to irrigation rates. But maybe it doesn't matter because we got the Tariff Acknowledgment Letter on Wednesday, the 12<sup>th</sup>. Is the Tariff Acknowledgment Letter the final step – we are good to go?

**Issue**

On January 21, 2025, Dixie made a filing with the Commission seeking to change energy charges on its rate schedules which contain a Wholesale Power Cost Adjustment clause (WPCA). The retail energy rates will increase by \$0.0020 per kWh. The irrigation second tier energy rates were increased by \$0.0020 per kwh. **The irrigation rates will be in effect for the months of March through May and October through February 2026.** Dixie intends to make the new rates effective as of March 1, 2025. On January 22, 2025, the Commission issued an Action Request to the Division asking the Division to investigate the application and to report back by February 5, 2025.
