**Re: Docket No. 26-035-T05
Rocky Mountain Power’s Proposed Revisions to Electric Service
Schedule No. 97 - Wildfire Mitigation Balancing Account**

On April 25, 2025, the Public Service Commission (“Commission”) of Utah issued an Order in Docket No. 24-035-04, the Application of Rocky Mountain Power for Authority to Increase its Retail Electric Utility Service Rates in Utah and for Approval of its Proposed Electric Service Schedules and Electric Service Regulations, approving recovery of \$6,347,730 through the Wildfire Mitigation Balancing Account, collected via Electric Service Schedule No. 97 (“Schedule 97”).¹

The Company expects the approved balance will be fully amortized by approximately May 15, 2026, and the Company now respectfully requests that the rate for Schedule 97 be reduced to zero, effective May 15, 2026. Redlined and clean versions of Schedule 97 with the proposed updates are attached to this filing. Any residual balance or overcollection will remain in the Wildfire Mitigation Balancing Account for collection or refund in a future proceeding.


