In its initial Order of September 28, 1988, approving Utah Power & Light Company ("UP&L") and PC/UP&L Merging Corp.'s application for merger, this Commission included as a condition of the merger, based upon Applicants' representations of merger benefits, that UP&L file a revised tariff within sixty (60) days of merger approval reducing prices to regular firm customers by two (2) percent. The Commission specifically directed that UP&L implement the reduction through general rates and that it spread the reduction evenly among regular firm customer classes.

Pursuant to the Commission's Order, UP&L has filed Utah P.S.C. Tariff No. 36, which supercedes and cancels Utah P.S.C. Tariff No. 35. The new tariff will become effective Friday, March 10, 1989. This tariff reduced UP&L's prices to its regular firm customers by two (2) percent or \$13,019,411.

The Division of Public Utilities has reviewed Tariff No. 36 and reports that it complies with the Commission's Order and recommends that it be approved as filed.

Based upon the foregoing, the Commission will make the following

NOW, THEREFORE, IT IS HEREBY ORDERED, that Utah P.S.C. Tariff No. 36, filed in this matter by UP&L to effect the two (2) percent price reduction ordered by the Commission, be and the same is approved and shall become effective Friday, March 10, 1989.
