By the Commission:

The Commission pursuant to its Order Suspending Report and Order dated September 29, 1988, held hearings on November 8 and 9, 1988 at which time the Applicants presented prefiled Fourth Supplemental Testimony and Exhibits specifying Applicants' analysis of the impact of FERC conditions on merger benefits and costs. Applicants' witnesses V. R. Topham, D. Steinberg, O. T. Colby, Jr., and F. N. Davis were cross-examined on the prefiled testimony by the Division of Public Utilities, the Committee of Consumer Services, other intervenors and the Commission.

At the conclusion of the submission of the above evidence, the Commission heard the parties regarding scheduling and after due consideration sets the following procedure in connection with this matter:

1. Discovery, regarding the Company's testimony on the issues presently before the Commission, by the Division of Public

Utilities, the Committee of Consumer Services and other intervenors shall be delivered to Utah Power & Light Company, 1407 West North Temple, Salt Lake City, Utah 84140, not later than close of business November 11, 1988.

Responses of the Applicants to that discovery shall 2. be submitted to the parties not later than close of business November 16, 1988.

Intervenors, including the Division and 3. the Committee, desiring to submit testimony relating solely to the impact of the FERC conditions on merger benefits and costs shall submit the same to the Commission and the parties by close of business November 21, 1988.

4. Hearings concerning these matters shall be held commencing on Monday, the 28th day of November, 1988, at 10:00 a.m. and shall continue through November 29, 1988, if necessary, to complete the same, in the Commission's hearing room, Heber M. Wells State Office Building, Fourth Floor, 160 East 300 South, Salt Lake City, Utah.
