

AMENDED NOTICE TO PARTIES REGARDING PETITIONS FOR REHEARING

ISSUED: December 30, 1988

BY THE COMMISSION:

On December 21, 1988, the Commission notified the parties that the effect of its Suspension Order issued October 26, 1988, was to toll the running of the 30-day review period and that our December 13, 1988 Order, by which we vacated the Suspension Order and reinstated the September 28, 1988 Order approving the merger, had the effect of restarting the review period.

However, the merger application was filed with the Commission on September 27, 1987, after the passage of the Administrative Procedures Act, but prior to the effective date thereof. Therefore, the previous law, Section 54-7-15, Utah Code, with its 20-day review period applies to any application for review in this case and the parties should have 20 days from December 13, 1988 within which to file such an application.

Therefore, we amend our previous notice and advise the parties that they have 20 days from the issuance of our December 13, 1988 reinstatement Order, or until <u>Tuesday</u>, <u>January 3, 1988</u> to renew or refile applications for review or rehearing.
