Based upon the Shareholders' Petition for Order of Stipulation of Agreed and Disputed Facts dated February 17, 1988, the Commission's Order for Stipulation of Agreed and Disputed Facts issued February 26, 1988, and the Commission's Order on this subject dated March 31, 1988, Applicants understand that the purpose of this exercise is for the parties to attempt to reach agreement on certain basic facts in order to avoid the presentation of evidence on matters not in dispute in the interests of administrative economy and expedition of proceedings.
