ORDER ON MOTION TO
MODIFY HEARING SCHEDULE

By The Commission:

This matter came on for hearing the 17th day of November, 1987, pursuant to the Motion to Modify Hearing Schedule filed by the Committee of Consumer Services. At the hearing, the Committee of Consumer Services proposed that the hearing schedule be modified as follows:

- February 22, 1988 Cut off of discovery to Applicants from Intervenor
- March 7, 1988 Cut off for discovery responses from Applicants
- March 28, 1988 Filing of testimony by Intervenor
- April 11, 1988 Applicants file rebuttal testimony
- April 25, 1988 Intervenor file surrebuttal testimony
- May 2, 1988 Hearings commence

At the hearing, the parties agreed to hold in abeyance the Motion filed by the Committee of Consumer Services until after the final filing of testimony by the Applicants, which is sched-


uled the 23rd day of November, 1987. It was further agreed that a technical conference be held after the filing for informal presentation and review of the various models which will be used in the final testimony installment and analysis of the Applicants.

Based thereon, and for good cause shown, the Commission issues the following


ORDER

Wells State Office Building, 160 East 300 South, Salt Lake City, Utah, for the presentation and review of the various models, then available for such presentation and review, used by the Applicants in their testimony and analysis of the proposed merger.


