Pursuant to Rule R746-100-10(B) of the Utah Administrative Code, Petitioners Department of Community and Economic Development and the Board of Business and Economic Development respectfully move that the Public Service Commission grant an extension of time of seven (7) working days regarding the time within which Petitioners may file their direct testimony.

The reason for Petitioners request is that Rick Mayfield, Director of the Division of Business and Economic Development, is in Europe and will be touring the Scottish Power

facilities, meeting with Scottish Power representatives and surveying Scottish Power's customers during the week of June 21-25, 1999.
