REVISED SCHEDULING ORDER

ISSUED: November 19, 2001

By the Commission:

Pursuant to a November 2, 2001, Motion by the Committee of Consumer Services (the "Committee") for an extension of time in the schedule for discovery and hearing in this matter, the Commission issued a Notice of Scheduling Conference for Friday, November 9, 2001. Prior to the date of the Scheduling Conference the Commission was jointly advised by the Committee and PacifiCorp that they, the Division of Public Utilities, and the Intervenors in this matter had reached agreement on a revised schedule acceptable to all parties.

Now therefore, after hearing from the parties and being fully advised, the Commission makes the following order regarding the schedule and procedure in this docket:

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that:

1. The following revised schedule shall apply in this case:

October 5, 2001	Intervention Deadline
January 18, 2002	DPU, CCS and Intervenors File Direct Testimony and Exhibits
March 4, 2002	All Parties File Rebuttal Testimony and Exhibits
March 25, 2002	All Parties File Surrebuttal Exhibits
April 1-5, 2002	Hearings

2. All hearings set forth in the foregoing schedule shall begin at 9:00 a.m. and shall be held in the Commission's Hearing Room No. 426, Fourth Floor, Heber M. Wells Building, 160 East 300 South, Salt Lake City, Utah, unless otherwise noted.

3. At the hearings scheduled in this matter, all pre-filed testimony will be received as exhibits, without being repeated verbally, but each witness will be given an opportunity prior to cross examination to make any necessary corrections and to give a summary of his or her testimony.

4. All discovery requests shall be in writing and shall be served upon legal counsel for the party from whom discovery is sought. Responses to discovery requests shall be in writing and shall be served upon legal counsel for the party making the request and upon legal counsel for any other party who, in writing, has requested such responses.

5. For discovery requests served prior to January 18, 2002, discovery responses will be served within 14 days after service of the request. For discovery requests served after January 18, 2002, discovery responses will be served within 7 days after service of the request.
