STATUS REPORT & NOTICE

1. On July 7, 2004, the Commission issued an Order directing the parties to meet and discuss generally the post May 2004 CO2 costs that are currently being booked into Questar's 191 account. The Division of Public Utilities was directed to report back to the Commission in 20 and 30 days.
2. On July 27, 2004, the Division filed its initial status report.
3. On August 3, 2004, parties met for over two hours to address issues concerning post May 2004 CO2 costs that are currently being booked into the 191 account. Questar made available technical people to present information and answer questions. This meeting was attended by representatives from Questar, the Division, the Committee and its consultants, and various other parties and participants.

4. It was agreed that the next meeting shall take place Monday, August 16, 2004, in room 427 from 2 p.m. until 4 p.m.

5. The discussions between the parties are focusing upon post May 2004 CO2 costs, and should not serve to delay issuance of a Commission order addressing CO2 costs incurred prior to that time.
