Pursuant to Utah Code Ann. § 63-46b-9 and Utah Admin. Code R746-100-7, ATK Thiokol Propulsion, Central Valley Water Reclamation District, ConAgra Beef Company, Great Salt Lake Minerals Corporation, IHC Hospitals, Inc., Western Electrochemical Company*, Wasatch Energy LLC, and The Utah Association of Energy Users (collectively, the “UAE Intervention Group”) hereby petition for leave to intervene in this proceeding.

In support of their petition to intervene, Petitioners state as follows:

1. Petitioners are gas transportation and/or sales customers of Questar Gas Company, or organizations that represent such customers.

2. The legal rights and interests of Petitioners may be substantially affected by this proceeding.

* Western Electrochemical Corporation (“WECCO”), a division of American Pacific Corporation, has already separately intervened in this matter to facilitate its ability to address specific issues of concern to WECCO. WECCO is also participating in this docket as a member of the UAE Intervention Group.

3. Petitioners have not fully determined the specific positions they will take or the relief they will seek. Petitioners seek to intervene for purposes of protecting their interests as they may appear, particularly on issues of relevance to large gas consumers.

4. The interests of justice and the orderly and prompt conduct of this proceeding will not be materially impaired by allowing Petitioners to intervene.
