3. August 15, 2005 Responsive testimony by Committee, Division and intervenors
4. August 22, 2005 Data requests due by 5:00 p.m.
5. August 29, 2005 Data responses due by 5:00 p.m.
6. September 16, 2005 Rebuttal to testimony filed on August 15
7. September 19, 2005 Data requests due by 5:00 p.m.
8. September 26, 2005 Data responses due by 5:00 p.m.
9. September 29, 2005 Surrebuttal to testimony filed on September 16

10. A hearing on this matter is scheduled to commence on October 6, 2005, at 9:00 a.m., in the Commission's main hearing room, at 160 East 300 South, Heber M. Wells Building, 4th Floor, Salt Lake City, Utah. As necessary, hearings will continue on October 7, 11 and 12, to begin at 9:00 a.m.

11. Public witness testimony will be received on October 6, 2005, commencing at 4:30 p.m., in the Commission's main hearing room.
