Dear Ms. Orchard:

This letter is to inform you that based upon positions taken in their respective testimonies, including rebuttal testimony filed on February 2, 2007, and on-going analysis, the Division of Public Utilities (Division), the Committee of Consumer Services (Committee) and Questar Gas Company (Company or Questar) have reached a settlement in principle. This includes elimination of GSS and EAC rates, and inclusion of those customers in the GS-1 class. It also includes the elimination of the ITS and IS-4 rates. This agreement is subject to final approval by the Committee, the Division's Director, and Questar's management.

As we discussed with you earlier this afternoon, we request that the hearing on Thursday, February 8th, be convened to receive testimony from any party who wishes to offer into evidence their testimony and for cross-examination. The bridge number would be available for those parties who wish to testify or cross-examine at the February 8th hearing. Furthermore, public witness hearings on February 8th in Salt Lake and on February 15th in Beaver, Utah would be held as scheduled. Immediately following the submission of testimony on February 8th, the Company, the Committee, and the Division propose that a settlement conference would be held during which the agreement in principle would be described and comments taken, and a bridge number would be available for that settlement meeting.

The Company, the Committee, and the Division intend to offer their prefiled testimony and, if a settlement is finally authorized by the some or all of the parties, evidence in support of the settlement, at a hearing expressly for that purpose, which you tentatively scheduled for February 28, 2007.
