As grounds for this Petition, Carbon County represents that:

1. Delynn Fielding, Economic Development Director, for Carbon County has been involved in the task force established by the Public Service Commission to review the GSS and EAC rate structure. The current GSS and EAC Rates of Questar Gas Company are a deterrent and impediment to economic development in many locations in rural Utah. While they did not directly participate the cities of Sunnyside and East Carbon have subsequently suffered. This impediment reduces growth in non-served rural areas which in turn negatively affects other rural areas.

2. The legal rights and interests of Carbon County may be substantially affected by this proceeding.

3. The interests of justice and the orderly and prompt conduct of this proceeding will not be materially impaired by allowing Petitioner[s] to intervene.
