1. On October 6, 2006, Questar Gas Company (Company) filed an application to remove GSS, IS-4, IT-S and EAC rates from its tariff in this docket. Questar Gas would like to modify the application in this docket as follows.
2. The rolling in of IS-4 customers into the I-4 rate schedule as explained in Paragraph 10 of the application would result in a 56.8% increase to the DNG portion of the I-4 rates. The main reason that the increase to the I-4 DNG rate was much higher than the proposed increases to the GS-1 and IT rate schedules is that the I-4 rate class is small, with little Dth usage. With the GS-1 and IT rate classes there is more significant Dth usage to absorb the rolling in of the expansion area customers.
3. After discussions with the Division of Public Utilities (Division) and the Committee of Consumer Services (Committee) regarding this filing, the Company is now

proposing to increase the I-4 rates in the same proportion as the IT rates are adjusted. As explained in Paragraph 11 of the application, the IT rates have been proposed to increase by 1.2%.

4. The application of a 1.2% increase to the DNG portion of the I-4 rates results in the proposed rates as shown on the tariff sheet attached as Amended Application Exhibit 1.1. The attached proposed Page 4-3 will replace that same sheet in Exhibit 1.4 of the original application.

5. The reduction of the proposed I-4 rate from the 56.8% increase to the 1.2% increase will result in a revenue decrease for the Company of approximately \$150,000, which the Company will absorb.

PRAAYER FOR RELIEF

6. The Company respectfully requests that the proposed tariff sheet (Page 4-3) shown in Amended Application Exhibit 1.1 be approved and made effective in conjunction with the other tariff sheets filed in this docket.
