ISSUED: May 29, 2008

By the Commission:

On December 27, 2007, the Commission issued a Scheduling Order in this docket setting a procedural schedule, including hearing dates, for various phases of this matter.

Hearings on revenue requirement issues other than rate of return were scheduled for June 19, 20, and 30 and July 1 and 2, 2008, with a public witness hearing on July 1, 2008. A hearing on rate of return was scheduled for May 21, 2008. On February 27, 2008, the Commission issued an Amended Scheduling Order Changing Hearing Dates. In that order, the hearing dates on revenue requirement issues other than rate of return were changed to June 30 and July 1, 2 and 3, 2008.

On May 16, 2008, a Revenue Requirement Stipulation (Stipulation) was filed by Questar Gas Company, the Division of Public Utilities, the Committee of Consumer Services, the Utah Association of Energy Users Intervention Group and Central Valley Water Reclamation Facility. A copy of the Stipulation is available on the Commission's web site, [www.psc.utah.gov](http://www.psc.utah.gov), or at the Commission's offices. The Stipulation, if approved, will resolve all issues on revenue requirement other than rate of return on equity. The Stipulation states that the parties to the Stipulation "are authorized to represent that the intervenors in this docket that have

not entered into this Stipulation either do not oppose or take no position on this Stipulation.”

Therefore, the Revenue Requirement Stipulation is unopposed.

The hearing on rate of return was held on May 21, 2008, as scheduled.

Based upon the foregoing and for good cause appearing, the Commission makes the following order.

**ORDER**

NOW, THEREFORE, IT IS HEREBY ORDERED that:

1. The previous schedule in this matter is amended as follows:
  - a. All aspects of the procedural schedule dealing with the filing of rebuttal and surrebuttal testimony and a joint issues list and position matrix on revenue requirement and hearings on revenue requirement are hereby vacated.
  - b. Hearing on the Revenue Requirement Stipulation will be held by the Commission on **Thursday, June 12, 2008, beginning at 3:00 p.m.** in Room 403, Heber M. Wells Building, 160 East 300 South, Salt Lake City, Utah.
  - c. The public witness hearing for interested persons to provide oral comments on revenue requirement issues previously scheduled for July 1, 2008 at 4:30 p.m. will be held by the Commission on **Thursday, June 12, 2008, beginning at 4:30 p.m. and continuing to 5:30 p.m.** (or later as needed to accommodate those in attendance) in Room 403, Heber M. Wells Building, 160 East 300 South, Salt Lake City, Utah. 6713, at least three business days prior to the hearing, to see if alternative times can be accommodated. Interested persons may also submit written comments to the Commission.

2. Except as specifically amended by this Order, the previous schedule in this matter shall remain in effect.

Real time broadcast of the audio portion of a Commission hearing will be available through the Commission's web site, [www.psc.utah.gov](http://www.psc.utah.gov). Audio files should be available at the web site after a hearing is completed.
