Questar Gas Company (Questar Gas), pursuant to Utah Admin. Code R746-100-4.D, hereby respectfully moves the Commission to enter an order in the form attached hereto, modifying the schedule in this matter as currently set forth in the Scheduling Order issued on December 27, 2007 to allow Questar Gas to modify the dates pertaining to Phase I (Revenue Requirement and Test Year Issues Schedule), Section B, Revenue Requirement, with respect to the dates of June 19 and 20. Questar Gas proposes the dates of June 30, July 1, 2, 3, 2008, for the hearing on revenue requirement matters. The Division of Public Utilities, the Committee of Consumer Services and Utah Association of Energy Users have represented to Questar Gas that these dates will work. Questar Gas believes that having the revenue requirement hearing on dates contiguous to each other will better accommodate the schedules of all witnesses. Questar Gas believes that having separate hearings for rate of return on May 21, 2008, and cost of service

on October 14 through 20, 2008, will allow the revenue require portion of the case to be heard in four days or less.

Based on the foregoing, Questar Gas requests that the Commission issue an order modifying the schedule as requested.
