By The Commission:

On April 21, 2008, the Commission issued a Scheduling Order in the above-entitled docket setting July 9, 2008, as the deadline for the Division of Public Utilities (“Division”) to file its Report of Investigation with recommendations and supporting testimony in this matter.

On July 2, 2008, the Division filed a memorandum requesting the Commission extend said deadline by seven business days to July 18, 2008. If said delay is granted, the Division recommends the corresponding deadlines previously set for filing of rebuttal and surrebuttal testimony, as well as hearing in this matter, be similarly extended. The Division states the Committee of Consumer Services and Questar Gas Company do not oppose its request, as long as the remainder of the schedule is correspondingly extended.

Wherefore, based on the foregoing information, and for good cause appearing, the Commission enters this Order canceling the hearing currently set to convene on August 21, 2008, and amending the schedule in the above-entitled docket as follows:
