Questar Gas Company (Questar Gas) moves the Utah Public Service Commission (Commission) to enter a Protective Order in this docket in the form attached, and in support of this Motion, states:

1. On or about August 14, 2008, U.S. Magnesium, LLC, filed a formal complaint against Questar Gas. Questar Gas submitted its Answer in response to the issues raised in the formal complaint on or about September 15, 2008. A scheduling conference was held on October 30, 2009. The Commission issued a Scheduling Order in this docket on November 3, 2008.

2. Much of the information Questar Gas will be sharing with the Commission, the Division of Public Utilities, and the Committee of Consumer Services is confidential.

3. The entry of the proposed Protective Order will provide Questar Gas protection to valuable confidential, trade secret and proprietary information.

4. The entry of the proposed Protective Order will afford protection to the Commission as well as parties who might review the information and subsequently be requested to reveal its contents inasmuch as the proposed Protective Order sets forth clear parameters for use of confidential information.

5. The proposed Protective Order is fair and equitable to all parties.

6. The proposed Protective Order is substantially the same as the Orders entered by the Commission in prior dockets.
