3 ADMINISTRATIVE LAW JUDGE MOOY: This is in
4 the matter of Questar Gas applications, three of
5 which. They are filed in Dockets Number: 08-057-23,
6 08-057-24, and 08-057-25.

7 I'm Sander Mooy. I've been designated by
8 the Commission to be the hearing officer for these
9 three proceedings. If we could take appearances
10 starting with you, Mr. Proctor.

11 MR. PROCTOR: Paul Proctor on behalf of
12 the Utah Committee of Consumer Services.

13 MS. SCHMID: Patricia Schmid with the
14 Attorney Generals Office representing the Division of
15 Public Utilities.

16 MS. LARKIN BELL: Colleen Larkin Bell
17 representing Questar Gas Company.

18 ADMINISTRATIVE LAW JUDGE MOOY: Thank you.
19 Prior to going on the record, we had a brief
20 discussion on the procedure we'll follow today. The
21 Commission will take administrative notice of the
22 applications and accompanying material supplied by
23 the Company in each, and also the Division of Public
24 Utilities memorandum submitted in each one, as well
25 as a cumulative memorandum, which is dated October

1 16, 2008.

2 Mr. Proctor, I actually don't have the
3 file with me. I'm not aware whether the Committee
4 filed --

5 MR. PROCTOR: The Committee was relying
6 largely on its analysis of work done by others. So
7 we had not filed anything formally.

8 ADMINISTRATIVE LAW JUDGE MOOY: Okay. Are
9 there any other documents or information which
10 parties wish to enter in that context? For the
11 documents you can ask for their admission, and for
12 the evidence I'll just take a proffer.

13 MS. LARKIN BELL: The Company would have
14 two exhibits that they would just like to offer
15 today, and those are the exhibits that would show the
16 tariff sheets and the rate impact to customers if all
17 three applications are approved.

18 ADMINISTRATIVE LAW JUDGE MOOY: Would
19 there be any opposition to the entry of those two
20 documents?

21 MS. SCHMID: No opposition from the
22 Division.

23 MR. PROCTOR: None, thank you.

24 ADMINISTRATIVE LAW JUDGE MOOY: They will
25 be admitted. Thank you.

1 Let's go off the record for a minute.

2 (Off the record from 9:33:19 to 9:33:33
3 a.m.)

4 ADMINISTRATIVE LAW JUDGE MOOY: We're back
5 on the record.

6 I've received on behalf of the Commission
7 two documents. One is marked QGC Hearing Exhibit 1,
8 which is comprised of the tariff sheets for combined
9 dockets 08-057-23 through 25. The other is marked as
10 QGC Hearing Exhibit 2, which is the summary of the
11 affect of the -- on a GS-1 typical customer, annual
12 consumption.

13 Do any of the parties want to make a
14 proffer relative to any additional evidence?

15 MS. SCHMID: Nothing from the Division.

16 MS. LARKIN BELL: No, nothing from the
17 Company.

18 ADMINISTRATIVE LAW JUDGE MOOY:
19 Mr. Proctor, does the Committee want to make a
20 proffer on any additional --

21 MR. PROCTOR: No, thank you.

22 ADMINISTRATIVE LAW JUDGE MOOY: Seeing no
23 further participants coming into the room, we'll take
24 the matter under advisement.

25 As indicated, the Commission will make an

1 effort to issue a written order prior to November
2 1st, and we anticipate that being today or tomorrow.
