The UAE Intervention Group (UAE) hereby moves the Commission to modify the December 29, 2009 Scheduling Order (Order) in this Docket by vacating the March 18, 2010, deadline for non-company direct testimony on rate of return and revenue requirement issues, as well as the remaining testimony filing deadlines contained in the Order. UAE is authorized to represent that at least Questar Gas Company, the Division of Public Utilities, the Office of Consumer Services, Nucor Steel, Salt Lake Community Action Program and AARP all support this Motion and that none of the supporting parties is aware of any party who objects.

This motion is being filed because the parties have been actively engaged in settlement negotiations over the past several weeks and have now reached an agreement in principle as to the Company's rate of return and revenue requirement. Moreover, the parties' stipulation will also deal with all cost of service, rate design and other issues in this docket. The parties' agreement in principle is subject to negotiation of a mutually acceptable written stipulation and

attachments, as well as necessary final client approvals. However, the parties believe that they will be successful in negotiating a final stipulation of this case in the near future and are thus requesting that the Commission vacate the existing testimony filing dates.

The Commission has set a Scheduling Conference in this docket for Tuesday, March 16, 2010, at 9 a.m. At that Scheduling Conference, the parties anticipate requesting a hearing date for consideration of the parties' stipulation.

Wherefore, UAE respectfully asks the Commission to suspend the testimony filing dates in this docket and to schedule a hearing on the parties' settlement at the earliest date convenient to the Commission and the parties.
